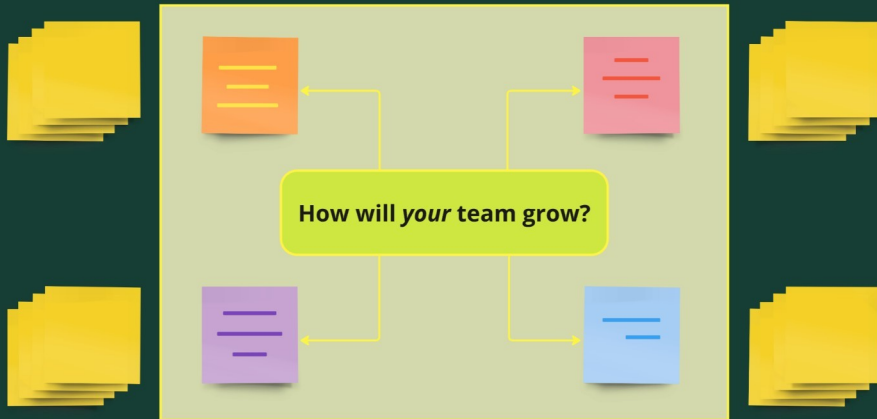




Setting Group Goals for Growth

Teams of 6-12 people will participate in a personalized visioning session with their own MSU Extension facilitation that will help them determine 5-7 priorities for future action.

SG3 is a 3-hour workshop that is offered several times a year, both in-person and online. You and your group can select the format that works best for you, online **OR** in-person.
