- **4-H Still Project Demonstrations/Performances/Public Speaking Presentations/Illustrated Talks:** Wednesday, September 18, 2024, 3:00 7:00 p.m. in the <u>TBD</u>.
- 4-H Animal Project Demonstrations: Wednesday, September 18, 2024, 3:00 4:00 p.m. at the photo wall.

Sign-up for a 10-minute time slot to do your demonstration/performance/public speaking presentation/illustrated talk will be handled as listed below under entry requirements.

ENTRY REQUIREMENTS: 4-H members planning on doing a demonstration, performance, public speaking presentation or illustrated talk at the St. Joseph County Grange Fair <u>must</u> meet <u>all three (3)</u> of the following entry requirements:

- Sign up for your demonstration/performances class(es) on the regular 4-H Fair Entry Form that is used for entering <u>all</u> your classes in the computer (with the exception of dogs, horses, and shooting sports). Fair entry forms are due in the St. Joseph County MSU Extension office by <u>Monday</u>, <u>August 12</u>, 2024.
- Complete a 4-H Demonstration/Performance/Public Speaking/Illustrated Talk Registration Form (attached) and return it to the St. Joseph County MSU Extension office by <u>Monday, August 12, 2024</u>. This form provides the St. Joseph County MSU Extension office with important information on the <u>type</u> of demonstration/performance/public speaking presentation/illustrated talk you will be doing.
- Sign-up for the time you will do your demonstration/performance/public speaking presentation/illustrated talk will be conducted on a first-come, first-served basis in Building No. 46 on Saturday, September 14, 2024, 8:30 a.m. 1:00 p.m. (this is the same time and location for picking up fair passes and still exhibit tags) or in the 4-H Fair Office on Sunday, September 15, 2024, 8:00 a.m. 5:00 p.m.

- 1. A <u>team</u> consists of two (2) exhibitors. A <u>group</u> consists of three (3) or more exhibitors. <u>Each</u> member of a team/group must complete a Demonstration/Performance/Public Speaking/Illustrated Talk Registration Form.
- 2. A different demonstration/performance/public speaking presentation/illustrated talk must be done each year.
- 3. <u>Trophies/plaques and rosettes</u> will be provided for <u>each</u> member of a <u>team/group</u> receiving a Best Performance or Best Demonstration award.

ADDITIONAL DEMONSTRATION RULES:

- Exhibitor may do one (1) <u>individual</u> and one (1) <u>team</u> demonstration in Department 73, Section C Animal Project Demonstrations and Section E - Public Speaking/Illustrated Talk.
- 2. Exhibitor must set up his/her own demonstration and furnish the necessary equipment. **Note:** An easel and a table will be provided at both the 4-H still project demonstration and animal project demonstration sites.

ADDITIONAL PERFORMANCE RULES:

A given exhibitor may make an <u>individual</u>, <u>team</u> and/or <u>group</u> class entry in <u>each</u> of the following performance-related departments, if desired, provided he/she has met general rule no. 1 listed above.
